## 2024 MEMBERSHIP CATEGORIES

**<u>Regular Membership:</u>** A full family membership limited to the following: a husband, wife, and children; a father and children; or a mother and children. A child is defined as a son or daughter eighteen years old or nineteen to twenty-three years old if attending a day school beyond the high school level as a full-time student. All must be listed as Dependents on your Income Tax Return. Privileges include the full use of all Club facilities. <u>Monthly restaurant minimums apply to this membership. \$200.00 Initiation/Application Fee Reguired</u>

**Social Membership:** A full family membership. Privileges include full use of all Club facilities except the golf course. Monthly restaurant minimums apply to this membership. \$50.00 Initiation/Application Fee Required

**Non-Resident Membership:** A full family membership defined as a member who lives outside of a 10-mile radius of the city limits of Sikeston.
